## **PRESIDENT'S MESSAGE** - Greetings from Alaska!

Belle and I have been traveling since April 1 and are now in Denali, Alaska. It has become very obvious to us that RV traveling has definitely decreased this summer, especially in Canada and Alaska. We have never seen a full RV park, and the number of Alaska-bound caravans is markedly reduced. Diesel prices in Canada are extremely high, in the low to mid five dollar range, and up to \$6 per gallon in outlying areas. Alaska isn't much better. Fairbanks was at \$4.81/gal when we left there a couple of days ago. We understand it is running about the same in Anchorage. Meanwhile, a quick check of the lower 48 states on the Internet shows that diesel is running around \$4.50/gal except in the far west where it is higher. We have heard from many people who are curtailing summer travels because of this and are "staying closer to home", or just "parking it this summer". Full-timers are staying in one place longer and not traveling as far between stops. The FMCA, our parent organization,

is experiencing reduced attendance at its rallies and conventions, probably because of this. Several motorhome manufacturers have closed their doors, and probably more will follow. Don't panic. The motorhome business/industry is a cyclical one. This particular "down-cycle" has been exaggerated by inflated diesel prices; I wish I could say how long it will last, but I cannot, because fuel pricing is a very complex geo-political issue that defies prediction. However, by adapting to market conditions according to our individual preferences, we can continue to enjoy our Alfas! Joining other members at our Pre Rallies or Rallies is a great way to do this. Though we had a great time at the Alfa National Rally in Montgomery, Texas before heading north, we were as surprised as everybody when it was announced about two weeks later that Alfa Leisure, Inc. was closing. There was no hint of this from anybody at the National, and sadly, the employees knew nothing about it either until that fateful day, April 30. All of this has led to many rumors and great speculation, but the truth of the matter is we won't know the end result(s) until after the fact. As I write this mid-June, the latest development appears to be that all of Alfa Leisure's assets will be sold at a public auction June 19 and 20. What next? Again, we'll have to wait and see.

Meanwhile, I am confident we have invested in a quality product. You hear from many people that Alfa coaches are the best value when it comes to features for a full-timer's motorhome. Its spaciousness and open-air feeling due to the high ceilings and large windows are the first thing mentioned, along with generous amounts of storage space. Though we are not full-timers, those features also attracted us to this coach, in addition to its being built on a quality chassis and powered by an excellent engine and transmission; all this at a very competitive price. That said, what about our future ownership, and repairs and maintenance? As it turns out, very few Alfa parts were actually made by Alfa. There are at least two repair facilities (and Dick Albritton in Louisiana) specializing in Alfa coaches (see their listings at the end of the President's Message). They have good lists of parts suppliers, so ongoing repairs and maintenance should not be a major problem. All of them are willing to share their sources and information. The two regular repair facilities are located in the west (Utah and California), so we do need a list of facilities elsewhere in the U.S. with whom our members have had good repair/maintenance experiences. I have asked our webmaster to initiate such a page on our website. By the time you read this newsletter, that page should be up and running. Please be aware that due to liability issues, we, as a club, are not endorsing these service

facilities. We are only reporting our members' recommendations. If you have had good service at a facility anywhere in the U.S., check to see if it is already listed on our website. If not, please send the information to our secretary, Karen Hugo ([KHugo@aol.com](mailto:KHugo@aol.com)) or me ([jfbohn1@mac.com](mailto:jfbohn1@mac.com)) so we may have it posted there. Please include information in a format similar to what is currently posted.

As you probably know, wiring layouts and other things were frequently changed during the production of our coaches. This can make coach repairs a challenging issue. Therefore, another thing we are looking into is establishing a database of coach wiring diagrams and other such technical information that may be of help to our members. There is a mixed variety of this information available, but we are having to check on proprietary issues before publishing it on our website. We will advise you of any progress with this matter in future newsletters.

Finally, even in these troubling times, it is still great to be an Alfa owner, and a member of the AlfaSeeYas. Our club is a superb resource for information, assistance and camaraderie as we travel, live in and enjoy our motorhomes. Right now, take a look at the address label on this newsletter and see if your membership is up for renewal. If so, don't delay, we'll appreciate your continuing support.

## **ALFA CLOSING! WHAT IS THE PRIMARY REASON FOR ALFA'S CLOSING?**

The following is a direct quote from the press release regarding the closure of the doors:

***"Ongoing challenges with key supplier Crane Composites further exacerbated the situation.*** (Crane manufactures the outer skin on the Alfa Motor Home that has been experiencing Osmotic blisters in recent years) *Alfa has been fighting an uphill battle and the final straw was certainly Crane's unwillingness to stand behind their product. There are currently no plans for additional operations and the company shutdown is just one of a growing number of RV manufacturers that have closed their doors. As housing values have dropped, many potential buyers have lost the equity in their homes they had in the past used to purchase big-ticket items".* (From the Sunrisers web site.)

**WESTERN GENERAL WARRANTY** (May 15, 2008)

I just got off the phone with the vice President of Marketing for Western General Insurance, Mark Edmundson, in regard to the 5 year Solid Gold Warranty they provided through Alfa. It covers model year 2005-2006, 5th Wheels & Motorhomes. If you have a contract in hand from Western General, you are covered for the term stated.

If you never received a contract from Western General, and are the owner of a Model Year 2005-2006, 5th wheel or Motorhome, Western General will honor the Solid Gold Warranty, even though they did not get paid by Alfa. In order to have them honor the contract, You must have proof of owning an Alfa RV that falls in the 2005-2006, model years. The following items constitute proof, and should have been in your rig when purchased.

A sample letter with specimen contract.  
A Western General brochure.  
There should also be a sticker in the rig stating that the Solid Gold Warranty is provided by Western General.

There may still be some model year 2005-2006 5th wheels & Motorhomes on dealers lots. Dealers are being instructed by Western General, to remove those materials referring to the Solid Gold contract from those rigs, and they will not be covered by Western General.

There has been some confusion and some folks have been told by Western General, that they are not covered. Mark assured me that they have all their people on board now, and as long as the above proof is shown, they will honor it.

Perhaps we won't be able to trade for a new Alfa in the future, but perhaps we'll become a 'Classic Motor Coach' club like old Hudsons or Model Ts.

Anyway, our affiliation with the members of these two clubs has enhanced our RVing experience far beyond what we could have imagined. We expect to stay connected to those who will accept us and may even have the opportunity to expand our numbers to those S. O. B.s who missed out on the Alfa experience first hand.

We have registered for the Sunriser's Hatteras, N. C. rally and intend to go to the events planned for Crossville, Tenn. and St. Augustine. Additionally, all thing being equal, I expect we'll attend the Tampa Super Show in January, and the FMCA Rallies in Brooksville and Perry next year. The two clubs can survive this. ## **PROTECT THE FRONT OF YOUR COACH FROM ROCKS, BUGS, ETC.**

(Courtesy of John Bohn) -- We met a caravan group with [www.rvalaskatours.com](http://www.rvalaskatours.com) in Whitehorse. The tailgunner for the group is Dean Price, a member of the AlfaSeeYas. When I saw his coach I thought he had experienced damage to the front, but as it turned out, he and all the other coaches have a saran wrap-like material called TransitShield applied to their units. This is to help protect against bugs, gravel, etc.

I bought a roll of it from them to put on our coach before we go to Chicken on the Top of the World highway, which is pretty rocky! I'll let you know how it works.

## **TIPS FOR EARTHQUAKE SAFETY** (From Dave Kiesig) Excerpts from an article by Doug Copp Rescue Chief and Disaster Manager of the American Rescue Team International (ARTI)

The information in this article will save lives in an earthquake.

Simply stated, when buildings collapse, the weight of the ceilings falling upon the objects or furniture inside crushes these objects, leaving a space or void next to them. This space is what I call the 'triangle of life'. The larger the object, the stronger, the less it will compact. The less the object compacts, the larger the void, the greater the probability that the person who is using this void for safety will not be injured. The next time you watch collapsed buildings, on television, count the 'triangles' you see formed. They are everywhere. It is the most common shape, you will see, in a collapsed building.

1) Most everyone who simply 'ducks and covers' WHEN BUILDINGS COLLAPSE are crushed to death. People who get

under objects, like desks or cars, are crushed.

2) Curl up in the fetal position. It is a natural safety/survival instinct. You can survive in a smaller void. Get next to an object, next to a sofa, next to a large bulky object that will compress slightly but leave a void next to it.

3) Wooden buildings are the safest type of construction to be in during an earthquake. Wood is flexible and moves and if it does collapse, large survival voids are created. Wooden buildings have less concentrated, crushing weight.

4) If you are in bed during the night and an earthquake occurs, simply roll off the bed. A safe void will exist around the bed, sofa, or large chair.

5) Most everyone who gets under a doorway when buildings collapse is killed. If you stand under a doorway and the doorjamb falls forward or backward you will be crushed by the ceiling above. If the door jamb falls sideways you will be cut in half by the doorway. In either case, you will be killed!

6) Never go to the stairs. The stairs have a different 'moment of frequency' (they swing separately from the main part of the building). The stairs and remainder of the building continuously bump into each other until structural failure of the stairs takes place.

8) Get Near the Outer Walls Of Buildings Or Outside Of Them If Possible - It is much better to be near the outside of the building rather than the interior. The farther inside you are from the outside perimeter of the building the greater the probability that your escape route will be blocked.

9) People inside of their vehicles are crushed when the road above falls in an earthquake and crushes their vehicles; which is exactly what happened with the slabs between the decks of the Nimitz Freeway. The victims of the San Francisco earthquake all stayed inside of their vehicles. They were all killed. They could have easily survived by getting out and sitting or lying next to their vehicles. .

10) I discovered, while crawling inside of collapsed newspaper offices and other offices with a lot of paper, that paper does not compact. Large voids are found surrounding stacks of paper.

Spread the word and save someone's life... The entire world is

experiencing natural calamities so be prepared!

**BEWARE OF NEW SCHEMES BEING USED.**

**CHEATING AT THE PUMPS????** How to check a diesel/gasoline pump to assure you are not being fleeced!

Whichever grade you are using, put EXACTLY 10 GALLONS in your tank then look at the dollar amount, if the dollar amount is not EXACTLY 10 times the price of the fuel you have chosen, then the pumps are rigged. If you do find a station is cheating, contact the State Department of Agriculture..... **you may also want to notify the police!**

**BEWARE OF PAPER ON THE BACK**

**WINDOW OF YOUR VEHICLE--NEW WAY TO DO CARJACKINGS**

Heads up everyone! Please, keep this circulating... You walk across the parking lot, unlock your car and get inside. You start the engine and shift into Reverse. When you look into the rearview mirror to back out of your parking space, you notice a piece of paper stuck to the middle of the rear window. So, you shift into Park, unlock your doors, and jump out of your car to remove that paper (or whatever it is) that is obstructing your view. When you reach the back of your car, that is when the carjackers appear out of nowhere, jump into your car and take off. They practically mow you down as they speed off in your car.

And guess what, ladies? I bet your purse is still in the car. So now the carjacker has your car, your home address, your money, and your keys. Your home and your whole identity are **now compromised!**

If you see a piece of paper stuck to your back window, just drive away. Remove the paper later. And be thankful that you read this you will tell your friends and family, especially to women. A purse contains all kinds of personal information and identification documents, and you certainly do NOT want this to fall into the wrong hands.

**DO YOU HAVE YOUR LICENSE PLATE?** With the dramatic

increase in the price of fuel thieves are stealing license plates from vehicles - attaching them to their vehicle, filling up their vehicle's fuel tank then driving off. What gets reported? The license plate number of that vehicle - YOUR PLATE NUMBER!

Should you find your license plate stolen report it to police immediately.

**JURY\_DUTY\_SCAM**, (courtesy of Tom Ingalls)

This has been verified by the FBI (their link is also included below). Please pass this on to everyone in your email address book. It is spreading fast so be prepared should you get this call. Most of us take those summonses for jury duty seriously, but enough people skip out on their civic duty, that a new and ominous kind of fraud has surfaced.

The caller claims to be a jury coordinator. If you protest that you never received a summons for jury duty, the scammer asks you for your Social Security number and date of birth so he or she can verify the information and cancel the arrest warrant. Give out any of this information and bingo; your identity was just stolen.

The fraud has been reported so far in 11 states, including Oklahoma , Illinois , and Colorado . This (swindle) is particularly insidious because they use intimidation over the phone to try to bully people into giving information by pretending they are with the court system. The FBI and the federal court system have issued nationwide alerts on their web sites, warning consumers about the fraud.

**ATTORNEY'S ADVICE - NO CHARGE** Read this and make a copy for your files in case you need to refer to it someday. Maybe we should all take some of his advice!A corporate

Attorney sent the following out to the employees in his company.

1. Do not sign the back of your credit cards. Instead, put "PHOTO ID REQUIRED."

2. When you are writing checks to pay on your credit card Accounts, DO NOT put the complete account number on the "For" line. Instead, just put the last four numbers. The credit card company knows the rest of the number, and anyone who might be handling your check as it passes through all the check processing channels won't have access to it.

3. Put your work phone # on your checks instead of your home Phone. If you have a PO Box use that instead of your home address. If you do not have a PO Box, use your work address. Never have your SS# printed on your checks. (DUH!) You can add it if it is necessary. But if you have it printed, anyone can get it.

4. Place the contents of your wallet on a photocopy machine. Do both sides of each license, credit card, etc. You will know what you had in your wallet and all of the account numbers and phone numbers to call and cancel. Keep the photocopy in a safe place. I also carry a Photocopy of my passport when I travel either here or abroad. We've all heard horror stories about fraud that's committed on us in stealing a Name, address, Social Security number, credit cards. Unfortunately, I, an attorney, have firsthand knowledge because my Wallet was stolen last month. Within a week, the thief(s) ordered an expensive monthly cell phone package, applied for a VISA credit card, had a credit line approved to buy a Gateway computer, received a PIN number from DMV to change my driving record information online, and more. But here's some critical information to limit the damage in case this happens to you or someone you know:

5. We have been told we should cancel our credit cards immediately. But the key is having the toll free numbers and your card numbers handy so you know whom to call. Keep those where you can find them.

6. File a police report immediately in the jurisdiction where your credit cards, etc., were stolen. This proves to credit providers you were diligent, and this is a first step toward an investigation (if there ever is one). But here's what is perhaps most important of all: (I never even thought to do this.)

7. Call the 3 national credit reporting organizations immediately to place a fraud alert on your name and also call the Social Security fraud line number. I had never heard of doing that until advised by a bank that called to tell me an application for credit was made over The Internet in my name. The alert means any company that checks your credit knows your information was stolen, and they have to

contact you by Phone to authorize new credit. By the time I was advised to do this, almost two weeks after the theft, all the damage had been done. There are records of all the Credit checks initiated by the thieves' purchases, none of which I knew about before placing the alert. Since then, no additional damage has been done, and the thieves threw my wallet away this weekend (someone turned it in). It seems to have stopped them dead in their tracks. ## **PASSPORT RULES Western Hemisphere Travel Initiative (WHTI) (from Travel.State.Gov)**

### **AIR TRAVEL**

**ALL PERSONS** traveling by **air** outside of the United States are required to present a passport or other valid travel document to enter or re-enter the United States.

### **LAND AND SEA TRAVEL**

The following summarizes information available on the [Department of Homeland Security's website](#)

#### **CURRENTLY:**

U.S. citizens need to present either (a) a passport, passport card (available in spring 2008), or [WHTI-compliant document](#); or (b) a government-issued photo ID, such as a driver's license, along with proof of citizenship, such as a birth certificate.

#### **LATER:**

On June 1, 2009, the U.S. government will implement the full requirements of the land and sea phase of WHTI. The proposed rules require most U.S. citizens entering the United States at sea or land ports of entry to have a passport, passport card, or [WHTI-](#)

[compliant document](#).

**Note:** The passport requirement does **NOT** apply to U.S. citizens traveling to or returning directly from a [U.S. territory](#).

**U.S. PASSPORT AND WHTI COMPLIANT DOCUMENTS:**

**U.S. Passport:** U.S. citizens may present a valid U.S. passport when traveling via air, land or sea between the U.S. and the aforementioned Western Hemisphere countries.

**[The Passport Card](#):** Passport card applications are currently being accepted in anticipation of land border travel document requirements. Based on current projections, we expect to begin production of the passport card in June, and be in full production in July. We will provide additional updates as available. Once in production, the passport card it will only be valid for land and sea travel between the U.S. and Canada, Mexico, the Caribbean region, and Bermuda.

**ABOUT WHTI**

The Western Hemisphere Travel Initiative is a result of the Intelligence Reform and

Terrorism Prevention Act of 2004 (IRTPA), requiring all travelers to present a passport or other document that denotes identity and citizenship when entering the U.S.

The goal of the initiative is to strengthen U.S. border security while facilitating entry for U.S. citizens and legitimate foreign visitors by providing standardized documentation that enables the Department of Homeland Security to quickly and reliably identify a traveler.
